B-Act WSP 20x100 g

Powder for drinking water (gut flora enhancing probiotic)

COMPOSITION: Preparation of *Bacillus licheniformis* containing a minimum of 1.6 x 10 ¹⁰ viable spores (CFU, colony forming units) per gram.

INDICATION: To provide a source of live, naturally occurring micro-organisms for stimulation of weight gain and improvement of feed conversion efficiency.

DIRECTIONS FOR USE: Administer to poultry via drinking water for a seven day period. One sachet (100 grams) typically treats 20,000 chickens per day.

MIXING INSTRUCTIONS: Prepare stock solution by performing the following steps:

- Add 1 sachet of 100 grams directly into 10 litres of water. Do not open the sachet. The sachet will initially float, then sink to the bottom of the bucket and dissolve within 5 minutes.
- Stir the solution once the sachet has fully dissolved after which B-Act WSP is ready to use in the drinking water system.

Stock solution may be used for up to 2 days.

Good drinking-line management is advised for optimal results with B-Act WSP.
